The District Superintendent & Chief Executive Officer of the CiTi BOCES serves the students, educators and school districts of our region in two important capacities. First, as District Superintendent, the selected candidate will act as the New York State Education Commissioner's official representative at the local level. Second, as CEO of the CiTi BOCES, the successful candidate will be the BOCES Superintendent, and will lead, develop and oversee shared service opportunities for the benefit of students residing within a nine component school district area.

As District Superintendent, the selected candidate will be one of thirty-seven District Superintendents statewide who work directly for the Commissioner. District Superintendents are responsible for certain statutory, regulatory and policy initiatives determined by the Commissioner. They provide regional leadership, consult with boards of education, assist local boards of education with superintendent searches, mentor superintendents of school, and more generally assist local school districts with their education initiatives.

As CEO of the CiTi BOCES, the selected candidate will act as the superintendent of the BOCES in a manner that is very similar to a local superintendent of school. The CiTi BOCES CEO will report to a nine member Board of Cooperative Education Services. As required by NYS Education Law, the District Superintendent & CEO of the CiTi BOCES will be appointed by the CiTi BOCES Board, only after receiving the Commissioner's formal approval.

- Citi BOCES Board appoints the District Superintendent & CEO.
- The Anticipated Start Date is April 21, 2025.
